## Review of ISB Case # I2020-017 Mr. Charles Johnson

Mr. Charles Johnson was sworn in by Chairman Kirkwood and was given the opportunity to give the board members his account of the events that happened on the day in question. Mr. Johnson gave the board a detailed description of the events in question. After his testimony, the Chairman gave the board members an opportunity to ask Mr. Johnson questions. After a brief question and answer period between Mr. Johnson and the board members, a witness statement from a store employee where the incident occurred was read by the board members. The witness in question was not in the meeting and was never sworn in. The board, along with Mr. Johnson reviewed the body camera footage taken that day by the arresting officer. We were able to finish reviewing the body camera footage from the officers involved. Upon reviewing the body camera footage, the board asked more questions of Mr. Johnson, and he answered all questions.

Chairman Kirkwood closed all discussion and opened the floor for a vote. Board Members were given the options to vote "SUSTAINED", NOT SUSTAINED, or SUSTAINED W/RECOMMENDATION"

Roll was called by CLERB secretary **Mr. Sandeep Pednekar**, and each board member cast their votes accordingly. All Board members voted" **SUSTAINED**" with two board members voting to "Sustained without recommendation" and the remaining ten voting "Sustained w/recommendations".
